LaBelle residents help hurricane victims

LABELLE — Fort Myers residents impacted by Hurricane Ian got a helping hand from LaBelle developer MJ Newell Homes on Sunday, Oct. 9. The developer coordinated efforts to distribute nonperishable necessities to the community at the Family Dollar Store in Fort Myers.

The event was the second held there in the past week, providing dry goods, nonperishable food, children's medication, water, juice and more to those in need after Ian ripped through the area, demolishing buildings and homes,

cutting off power and causing the Caloosahatchee River to rise to devastating levels.

The event began at 11 a.m., according to a Standard Land Development spokesperson on Oct. 10, ending about 5 p.m. Standard Land Development is the parent company of MJ Newell Homes, and its daughter companies Standard Land Development Landscaping and Standard Land Development Hauling transported truck loads of supplies and food to the location for distribution. Referendum benefitting Hendry Co. schools to appear on ballot

LABELLE — A half-cent sales surtax referendum will be included in the November 2022 ballot. This referendum is designed to fund much-needed improvements throughout the Hendry County School District with all funds remaining within the county.

If passed, the tax would be applied to select goods and services sold throughout the county, however, the tax would not be ap-

plied to groceries, gasoline, or prescription medication.

More than 7,000 students attend Hendry County schools and will benefit from the funds if the referendum passes in November.

If passed, the Hendry County School District plans to renovate schools or construct new ones to allow growth and keep up with the expanding population. New technology and

HURRICANE DAMAGE

Agricultural losses estimated up to \$1.56 billion

The combination of seasonal crops, livestock, nursery and aquaculture products potentially lost as a result of category 4 Hurricane Ian will likely be valued between \$787 million and \$1.56 billion, University of Florida economists predict. The estimate was released as part of a new document, "Preliminary Assessment of Agricultural Losses and Damages Resulting from Hurricane Ian," from the UF/IFAS Economic Impact Analysis Program.

"Even though the coast — an area with comparatively less agricultural production than inland areas — bore some of the worst impacts of the storm, the strong winds and heavy rains battered a wide swath of the peninsula that includes over 5 million acres of agricultural land," said Christa Court, director of the program and assistant professor in the UF/IFAS food and resource economics department. "This estimate only accounts for production losses, or changes in expected revenues for the current calendar or market year; citrus, for example, had not yet begun harvesting, and some fall

vegetables, like tomatoes and peppers, were already planted."

Some commodities were already looking at lower expected production due to a hard freeze event in January that affected much of the same acreage, she added. The UF/IFAS Economic Impact Analysis Program conducts assessments after any event that disrupts the standard operations of Florida's agriculture industry; usually, the surveys are deployed after natural disasters like hurricanes, floods and freezes, but have more recently included assessments of the impacts from the COVID-19 pandemic.

"Southwest counties that got hit the hardest by Hurricane Ian have remained in rescue and recovery mode; we anticipate our assessments will not be complete for several weeks," Court said. "Our preliminary estimate is a range, a wide range, to account for many of these unknowns. What isn't destroyed might have diminished yield or quality, which will not be apparent for weeks or months, and then even more effects can appear in the long-term."

Court and her colleagues

began collecting baseline data for agricultural losses and damages resulting from tropical cyclone events in 2016. Since then, the program has continued to improve its baseline and impact databases for these types of analyses.

Even with this comparison data available to the research team, analyzing Hurricane Ian's impacts remains complicated, as the preliminary assessment notes. It made landfall not far from 2017's Hurricane Irma, but it cut across toward the east coast, rather than north through the entire peninsula. More importantly, Ian was a more powerful storm, bringing hurricane-strength (74-156 mph) winds to nearly 1.2 million acres of agricultural lands.

To assist with the preliminary analysis, the UF/IFAS Economic Impact Analysis Program used data from multiple sources, in addition to its previous post-storm assessments. The National Hurricane Center's imagery of the storm was combined with geospatial data from the Florida Department of Agriculture and Consumer Services (FDACS) and information from USDA Na-

tional Agricultural Statistics Service (USDA-NASS) on croplands in the area, including the seasonal planting and harvest times. The researchers then used additional information from the United States Department of Agriculture (USDA)'s United States Census of Agriculture, Ask IFAS, and the Federal Emergency Management Agency (FEMA). Once the impacted agricultural acreages were determined, the team used a five-year average for value per acre of each com-

modity group to estimate the total "at-risk" production value across affected acres. The total value of all the croplands that saw tropical storm or hurricane conditions topped \$8.1 billion.

Despite heavy flooding prohibiting full assessments of some fields, the researchers collected some visual assessments. Among their predictions:

- Citrus crops are expected to sustain significant production losses (\$147 million to \$304 million), depending on the level of fruit

drop, damage to branches, and impacts due to heavy precipitation and flooding.

- Vegetables and melons are expected to sustain significant production losses (\$208 million to \$394 million), with impacts heavily dependent on the ability to replant damaged or destroyed crops.

- Livestock operations and producers of animal products are expected to suffer losses (\$113 million to \$222 million) due to damaged fencing, power outages and flooding.

FRAUD ALERT

Con artists prey on disaster victims

ATLANTA — Disaster survivors should be aware that con artists and criminals may try to obtain money or steal personal information through fraud or identity theft after a disaster. In some cases, thieves try to apply for FEMA assistance using names, addresses and Social Security numbers they have stolen from survivors.

If a FEMA Inspector comes to your home and you did not submit a FEMA application, your information may have been used without your knowledge to create a FEMA application. If so, please inform the inspector that you did not apply for FEMA assistance so they can submit a request to stop further processing of the application.

If you did not apply for assistance but receive a letter from FEMA, please call the FEMA Helpline at 800-

621-3362.

If you do wish to apply for FEMA assistance after stopping an application made in your name without your knowledge, the Helpline will assist you in creating a new application.

FEMA Disaster Survivor Assistance teams, housing inspectors and other officials will be working in areas impacted by Hurricane Ian in Florida. They carry official identification badges with photo IDs. FEMA and U.S. Small Business Administration representatives **never charge applicants for disaster assistance, inspections or help in filling out applications.**

- Don't believe anyone who promises a disaster grant in return for payment.

- Be wary of unexpected phone calls or visits to your home from people claiming to be FEMA housing inspectors or people claiming they work for FEMA. FEMA representatives will

have your FEMA application number.

- Don't give your banking information to a person claiming to be a FEMA housing inspector. FEMA inspectors are never authorized to collect your personal financial information.

If you believe you are the victim of a scam, report it immediately to your local police or sheriff's department or contact the Office of the Attorney General by calling 1-866-9-NO-SCAM (1-866-966-7226) or visit myfloridalegal.com. To file a fraud complaint, go online to Scam Report (myfloridalegal.com).

QUALITY CARE

National changes affect small healthcare systems

CLEWISTON — Patients and families know quality care when they experience it. A nurse's response time, a doctor's bedside manner, the hospital's atmosphere - all these things affect how people feel about the quality of their healthcare.

The Centers for Medicare & Medicaid Services (CMS) and the nation's hospitals work collaboratively to publicly report hospital quality performance information on the CMS Care Compare

website. Changes made by CMS are affecting small healthcare systems' star ratings like Hendry Regional Medical Center (HRMC).

When hospitals talk about quality, it is generally in reference to very specific clinical data collected and analyzed over a period. Quality data show how well a department or institution achieves desired health outcomes for a particular procedure, often by tracking how closely clinical staff meet standards of care.

"We place a strong emphasis on quality data measurements and reporting. It is how we hold ourselves accountable to the community and public in providing not just quality healthcare but excellent healthcare," stated Dakota Redd, Chief Nursing Officer, HRM.

While Hendry Regional does participate in outpatient and inpatient quality data reporting with CMS, with the new changes there are now too few measures/measurement groups reported or

cases/patients are too few to calculate a star rating.

What does this mean? HRMC previously held a 3-star rating, higher than many other local hospitals, however a star rating is no longer available (N/A) on the CMS Care Compare website.

"It is important to note that while CMS no longer recognizes HRMC with a star rating, we would have maintained a 3-star rating if those changes had not gone into effect based on the data we continue to submit," stat-

ed Redd. "We are proud of the excellent healthcare we provide and that is witnessed by all our patients who receive care at HRMC regardless of a star rating."

In reviewing HRMC's quality data, they score well above the national and state average in most areas. Striving to ensure that the care provided

is safe, effective, patient-centered, timely, efficient, and equitable.

In a continued effort of transparency HRMC will be making even more data available in the coming months. To view HRMC quality data or to learn more, visit hrmc.us.

Free Naloxone available at Health Depts

2. Administer Naloxone
3. Call 911
4. If necessary, give second dose (in other nostril).

A medicine that rapidly reverses an opioid overdose by attaching to opioid receptors, and reversing and blocking the effects of the drug.

RECIPE OF THE MONTH

Pumpkin Cornbread Muffins

Ingredients

- 1 cup pumpkin purée
- 2 eggs
- 1/2 cup packed brown sugar (light or dark)
- 1/3 cup vegetable oil
- 2 Tbsp molasses
- 1/3 cup buttermilk (substitute milk or half and half)
- 1/2 tsp cinnamon (substitute cardamom or ginger)
- 1 tsp salt
- 1 Tbsp baking powder
- 1 cup cornmeal
- 1 cup all purpose flour

Instructions

- Preheat oven to 375F.

Grease and flour a muffin tin, or use paper muffin liners.

- In a large mixing bowl, whisk the first 8 ingredients together (pumpkin through salt.) Make sure everything gets well incorporated.

- Whisk in the baking powder, corn meal, and flour, mixing until just combined, but don't over beat this. I usually switch to a silicone spoon at the end.

- Use a standard ice cream scoop to fill 10-12 muffin cups fairly full. My muffin tin is on the large size so I got 10 muffins from my batter.

- Bake for about 20-22 minutes until the muffins

are fully risen. The tops should spring back when lightly touched. If your muffins are smaller than mine they will take a shorter time. Try not to over bake as they will dry out.

- Let the muffins cool for about 10 minutes in the tin, and then run a blunt knife around the edges to loosen before turning out onto a cooling rack. If you use muffin liners you can pop them out immediately.

- Serve warm with butter and honey. The muffins can be reheated for 20-30 seconds in the microwave.

School district approves funding for repairs after Ian

CLEWISTON — Hendry County School District voted 5-0 to approve funding for emergency purchases related to Hurricane Ian with a cap of \$50,000 per incident.

Superintendent of Schools Michael Swindle made the request during the Oct. 4 school board meeting in Clewiston, saying that he isn't expecting any major repairs due to the hurricane.

"There are some things that staff needs to do," he said. "Like hire a tree-trimming company to come in and do the heavy lifting of part of it."

Some aluminum awnings need replacement which are going through the

usual procurements. Facilities, Maintenance & Transportation Director Anthony Busin estimated repairs to be approximately \$21,000, although he has submitted purchase orders for some minor repairs already.

The approval means damages can be addressed in real time without having to wait for various repair approvals under normal circumstances.

In other business, the board unanimously approved allocation for a physical education paraprofessional coach at LaBelle Middle School where, due to increased enrollment, some P.E. classes have up to 118 students. LMS currently has two P.E. coaches.

Out-of-field teacher lists

were also approved by the board. The term refers to teachers providing instruction for a subject their current certification is not recognized as appropriate for the particular assignment. It also includes teachers who do not have a ESOL certification, required upon hire for teaching English as a second language and something not easily obtained according to ESLTeacherEDU.com.

Swindle said out-of-field teachers are allowed five years to obtain the certification and hopes upcoming teacher negotiations will make the effort more attractive to teachers without it, so it can be more easily achieved and thus out of the way.

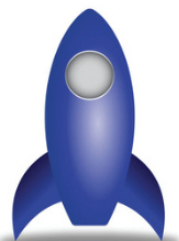

ONLINE TEACHING SERVICE

School district contracts with classroom streaming service

CLEWISTON — Hendry County School District will contract with an online teaching program to fill the gaps left by the teacher shortage it is experiencing, along with many schools in the country.

Superintendent Michael Swindle said online teaching isn't the best way in his opinion to run classrooms, but considering the difficulties finding local teachers nearly impossible, suggested the district contract with Elevate K-12, which provides

certified teachers that will livestream classroom instruction to schools.

The school board has grappled to employ teachers for the 2022-2023 school year by hiring uncertified military veterans and importing teachers from out of the country to fill in the numerous open slots in the ever-increasing school district.

"We are still struggling with teachers," Swindle told the board during its Oct. 4 meeting. "And this is an effort on our behalf to bring teachers in to the district that's able to deliver

high quality instructions to our students."

He cited Clewiston High School's physics class, which has students but no teacher. He proposed focusing on math and science teachers through the streaming classroom option.

Swindle said the option could be considered a pilot program for the school district due to the flexibility of Elevate K-12's contract which can be discontinued without penalty at any time.

Staff interviewed three educational streaming companies nationwide,

he said, and all of them reported they had plenty of certified teachers on hand with five or more years of teaching experience, ready to work. Many are teachers who have left the classroom have maintained their certification, turning their focus to programs such as Elevate K-12.

"Elevate K-12 had a very robust proprietary platform that I felt very comfortable with, and inadvertently they had the lowest price point for us," he said.

Elementary and Secondary School

Emergency Relief (ESSER) funding will be used to pay for the program.

"Basically, what we did was what our teachers typically do, which is six periods at 60 minutes and that works out to I think \$63,000 which, with benefits, is pretty much what we pay [existing district teachers]," Swindle said, adding that there are instructors for just about every school subject including foreign languages.

"We're hoping to not use them except for shoring up that we really need," he said. "And the physics class

is a prime example of that."

Swindle said that classroom management was still going to be the responsibility of the school district, and that means finding parents to be present during the livestream events. While he didn't think that would be a problem, he said he thought substitute teachers could be replaced by parents if there were enough of them.

"Again, we would rather have teachers," Swindle said. "We can't hire teachers."

The board voted 5-0 to approve the contract.

HCSD waives degree requirement for veteran teachers

LABELLE — United States military veterans will be given priority for teaching positions in Hendry County School District.

The school board voted 5-0 to move forward with a notice of a series of proposed rules during its Sept. 6 meeting, which included a reading of a "preference for veterans in employment" document.

The document states veterans – and in some cases spouses and immediate family members of veterans – be given preference in employment, promotion, retention and re-employment if they meet the

minimum eligibility requirements and have the "knowledge, skills and abilities required for the particular position."

While veterans are commonly given preference over other applications for many jobs, the school board is looking over its policy to reflect recent legislation signed into law by Gov. Ron DeSantis this year allowing veterans a temporary teaching certificate without the benefit of a bachelor's degree.

Florida requires teachers to hold a bachelor's degree and complete a state-approved teacher education program to become certified to teach in public

schools.

The current document states that spouses and in some cases immediate family members may be given preference over other applicants, however according to the Florida Department of Education (FDOE), the allowance does not apply to either group.

Veterans without a bachelor's degree must meet the following criteria as outlined on the FDOE website:

"A minimum of 48 months of military service with an honorable/medical discharge;

Minimum of 60 college credits with a 2.5 grade point average;

Passing score on a

Florida subject area examination;

Employment in a Florida school district, including charter schools; and

Cleared background screening."

Veterans who obtain the five-year temporary teaching certificate will be assigned a mentor teacher for a minimum of two years; must earn their bachelor's degree during the five-year period to be eligible for a full professional certificate and may not teach subjects requiring a master's degree.

The temporary certificate cannot be renewed once it expires.

The proposed school

district preferences will be applied to "disabled veterans; the spouse of a disabled veteran or of a person missing in action, captured in the line of duty or forcibly detained

by a foreign government while in the line of duty; a wartime veteran who has served at least one day during a wartime period; the widow or widower of a veteran who died of a service-connected disability; the mother, father, legal guardian or widows or widowers who have not re-married of a veteran who died of a service-connected disability or who died in the line of duty; and current

members of any reserve components of the U.S. Armed Forces or Florida National Guard. Active duty for training is not considered eligible."

Superintendent Michael Swindle said in July that the school district would be actively recruiting military veterans due to the severe teacher shortages, which he said are not limited to Florida but are state-wide.

LaBelle man charged with death of ex-wife

LABELLE — On Friday, Oct. 10, Hendry County Sheriff's Office Major Crimes Unit officially charged 43-year-old Ian Baunach of Ft. Denaud in the death of his former wife, 39-year-old Katie Samantha Baunach.

During the morning hours of Thursday, Sept. 30, Hendry County Sheriff Steve Whidden received

a call from a friend of Katie Samantha Baunach, reporting that she was concerned for her safety. She reported that the night before Katie had left

her two children in her care to go to the home of her former husband Ian Baunach to retrieve some of her personal items. Friends and family had not heard from

her nor have been able to reach her on her cell phone.

When deputies arrived at the home and were unable to contact either Katie or Ian Baunach, detectives requested a search warrant. A search warrant was obtained and deputies along with the Hendry County Sheriff's Office Special Response Team

responded to the home. During the search detectives found a large amount of steroids within the home, to which Ian admitted belonged to him.

Ian was then placed under arrest and charged with 13 charges of possession of controlled substance without a prescription and transported to the Hendry County Jail.

Still unable to locate Katie, a second search warrant was obtained for the home and property.

It was during this four day search, detectives were able to determine that remains found on the property were those of Katie.

On Oct. 10, at approximately 5 p.m., Hendry County Sheriff's Major Crimes Unit charged

Baunach with first degree pre-meditated murder; destruction/conceal physical evidence, use of two-way communication device to facilitate a felony, cremate dead body 48 hours after death and failure to report death to medical examiner.

Baunach is currently being held in the Hendry County Jail with no bond.

HCSO begs commission for more deputies

LABELLE — Hendry County Sheriff Chief Deputy Kevin Nelson begged county commissioners Sept. 26 to increase its 2022-2023 budget to allow for at least two more patrol deputies.

The department had requested funding for 19 new positions in the proposed budget, but only got enough for four, which is not nearly enough to cover the rapidly growing population.

"What I'm going to ask you to do is try to sharpen your pencil a little bit and give us two more," Nelson pleaded with commissioners during its regular board meeting when the final \$98,495,804 county budget

was set to be approved.

"When we come in to ask for something, it's because we need it, not because we just want to see a bunch of new people," he said.

Deputies are currently stretched too thin, and there is danger that with the growth in the county, they won't be able to keep up with demand even though the City of LaBelle committed to paying for two day-shift deputies for increased coverage there. That will ease the burden a bit.

The proposed tentative budget Sept. 26 left the sheriff's department with a choice to hire two more deputies or give existing deputies a raise. Nelson said the department will

give them a cost-of-living increase and the state of Florida will give them a salary adjustment. In the end, the sheriff's department felt forced to forego raises in favor of hiring the additional deputies.

Nelson complained that the department only has a handful of senior officers left, as most have gone to other agencies where they can make \$10,000-\$12,000 more. Additional deputies translate into a better response time for the public, Nelson said.

"When they (public) call, they sometimes complain we're not getting there quick enough," he said. "People are upset by the time we get there. We get there as quick as we can,

but we're busy."

With only two or three deputies working a shift, calls have to be prioritized and minor calls get pushed to the back on busy days.

"One highway crash takes up the whole shift for two or three hours sometimes," Nelson said.

Commissioners agreed there is a need to spend the additional \$158,000 estimated to cover two deputy salaries, but not sure where it would come from.

Commissioner Ramon Iglesias suggested it might be drawn from the catastrophe fund as a last resort to be repaid as soon as possible. Another option might be the \$4.5 contingency fund.

Ultimately, the board

voted 5-0 to approve the additional \$158,000 for two deputies to come from the contingency fund in the proposed budget, with a recommendation at its first meeting in October to have an amendment to

that budget as to where the funds will be moved from.

The commission also approved the final millage rate of 7.1000 which is 8.14% higher than the rollback rate of 6.5653.

Fisheating Creek offers outdoor adventures

GLADES COUNTY – Few places in Florida can match Fisheating Creek Wildlife Management Area for its range of activities and wilderness setting.

Fisheating Creek meanders through banks lined with cypress and oaks. Expect to see numerous alligators and a variety of birds. Rent a canoe, kayak or stand up paddle board (SUP) in the campground or launch your own from the campground or the Main Street access. Fisheating Creek Outpost offers a livery service with two drop-off points upstream of the campground, creating options for an eight-mile trip (from Burnt Bridge) or a 16-mile trip (From Ingram's Crossing). Water levels vary widely; check current conditions before planning your paddling trip.

The fall is the time to hunt for deer and feral hog on Fisheating Creek Wildlife Management Area. The best conditions for hunting deer are when water levels are down in the creek but not so low as to make travel by boat impossible. In the spring, turkey hunts are popular and usually yield excellent results. Paddling is best during high water, which usually occurs in late July, August, and September. High water may also occur following winter cold fronts.

Enjoy fishing anywhere along the creek either from a boat or along the bank. These tea-colored waters are home to bass, crappie, catfish and bream, as well as the nonnative armored catfish and tilapia.

Fisheating Creek WMA is an excellent place to view wildlife year-round. Wading birds, hawks, osprey and owls are common. White-tailed deer and Osceola turkey are frequently spotted and alligators are prevalent. Large numbers of migratory swallow-tailed kites gather here in late summer.

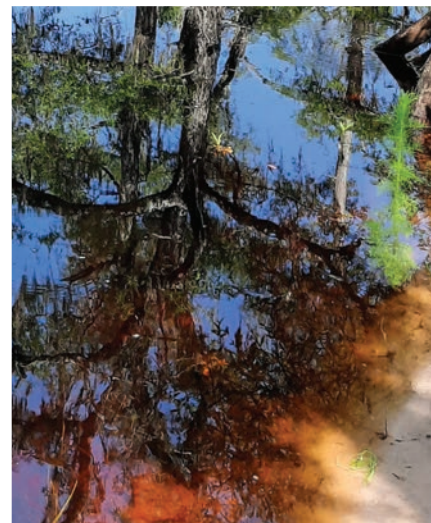
This area is part of the Great Florida Birding and Wildlife Trail. Enjoy year-round hiking and bicycling the WMA. Trails are prone to seasonal flooding; the January through May period offers the driest conditions.

Primitive camping is permitted year-round throughout the area. For full hook-up RV sites and primitive campsites within the concession-operated Palmdale campground, visit Fisheating Creek Outpost. The campground offers restrooms, showers and a camp store. During established hunting seasons, individuals are encouraged to camp at the Palmdale campground or at designated sites along Fisheating Creek. Weekends and cooler months are the busiest, so plan accordingly.

The entrance to the campground is 7555 U.S. 27 in Palmdale. For more information, go online to fisheatingcreekoutpost.com/

Access road cut off from Moss Landing

LABELLE — Moss Landing residents may be getting closer to having access road problems resolved after a discussion between a resident and the Clewiston Board of Commissioners Oct. 18.

Nikki Yeager, a Moss Landing resident who has spearheaded efforts to make the intersection on SR 80 and Martin Luther King Jr. Blvd. safer for the 55-plus mobile home community, told the commission the only alternative route to the highway, Shady Oaks Lane, has been blocked off, forcing residents to travel through the

Belle Arbor housing development on Aqua Isles Blvd. “It’s a major problem,” Yeager said. “Especially when all of the northerners come down and they can’t see, and they can’t hear.”

It is not the first discussion residents have had with the commission regarding the intersection and possible relief, the latest one in March, wherein it was pointed out the Florida Department of Transportation (FDOT) was responsible for the roadway and is undertaking a study to determine if a traffic signal there is warranted.

But that might take several years, and City

Attorney Derek Rooney suggested FDOT might move the project up if the city expressed an interest in installing a signal itself.

“They don’t want the city to do that,” he said.

FDOT is undertaking a study of the intersection before committing to any changes to the intersection, Mayor Julie Wilkins said, adding she would prefer the closed road be reopened to Moss Landing residents could access it.

Initially, Yeager thought the road through Belle Arbor was private, but the commission said it had been returned to the city, but not for maintenance purposes.

The Florida Department of Transportation (FDOT) has rescheduled a workshop for the SR 29 Project Development & Environment (PD&E) Study Re-evaluation from CR 80A (Cowboy Way) to north of CR 731 (Whidden Road) in Hendry County.

The in-person meeting will now take place on Wednesday, Nov. 30, 2022 at 5 p.m. at the original location – LaBelle Civic Center, 481 W. Hickpochee Ave., LaBelle, Florida 33935, and the virtual meeting will now take place on Thursday, December 1, 2022 at 6 p.m. The public meeting was originally scheduled in-person for Wednesday, October 26, 2022, and virtually on Thursday, October 27, 2022. Meetings for this project are being rescheduled due to Hurricane Ian.

The purpose of this PD&E Study Re-evaluation is to improve traffic operations, access, and mobility along SR 29. FDOT anticipates this project will also enhance safety along the project corridor; improve emergency evacuation; and improve access between Hendry and Glades

Counties. The project will widen sidewalks along the corridor and look at improvements at the intersections of SR 29 and Cowboy Way, SR 80 at Main Street and Bridge Street, and Park Avenue at Main Street and Bridge Street. The no-build alternative, where no improvements other than routine maintenance are made to SR 29, will remain viable throughout the remainder of this study. The PD&E Study Re-evaluation Workshop is being held to present information regarding the proposed design to SR 29 and to gather feedback from the public.

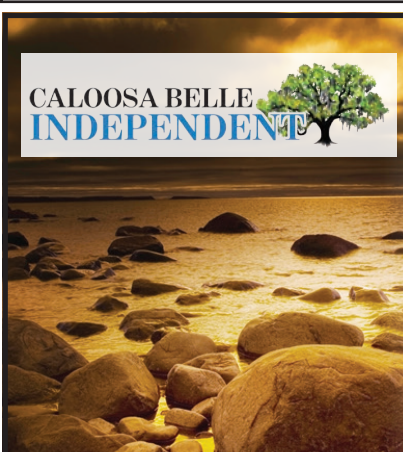

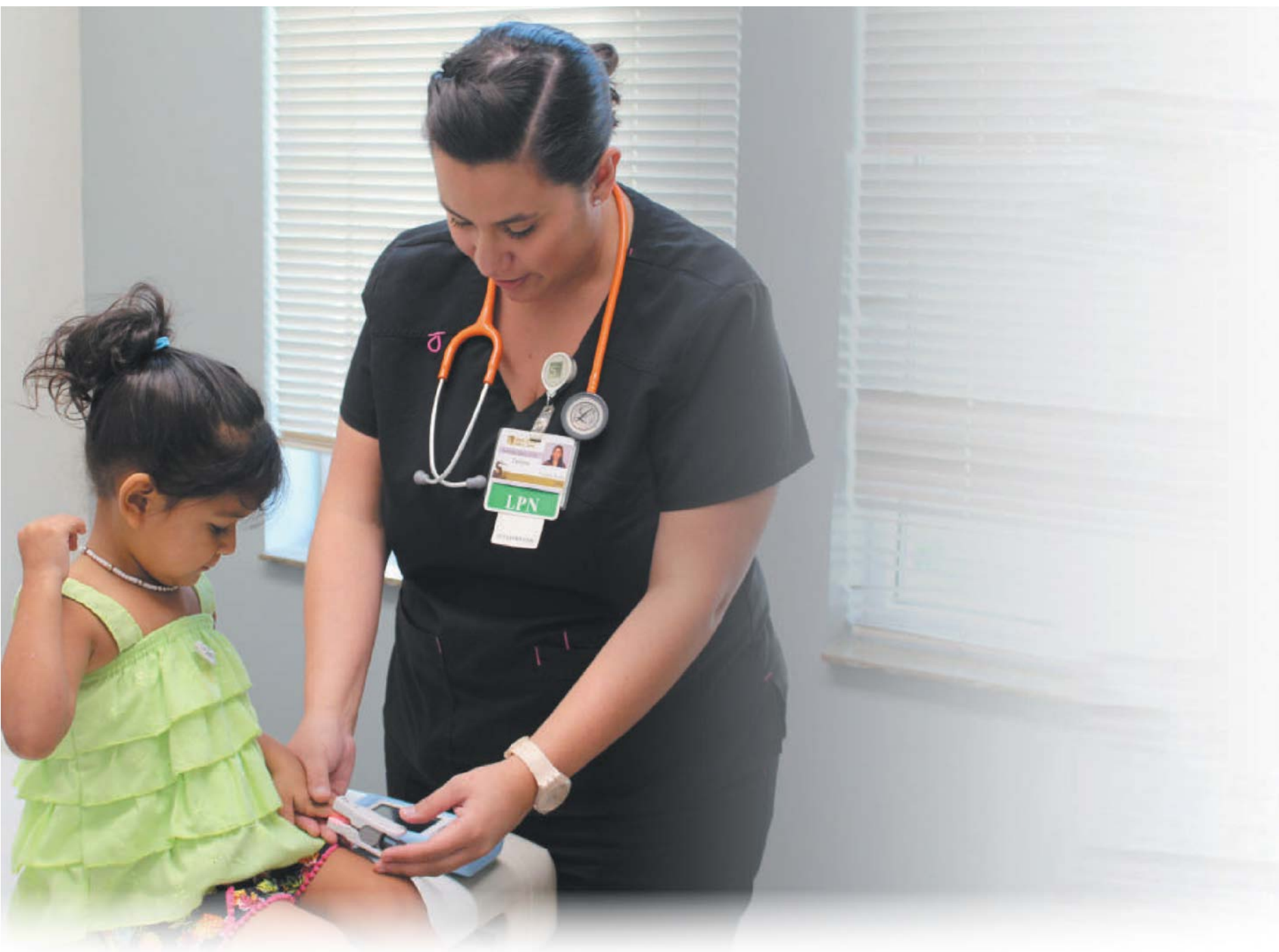
